3. Only painters tape is permitted for signage. Any other type of tape or adhesive will damage the trailer's exterior: repair is at the Lessee's expense
4. No credit will be provided for damaged, partially consumed or opened packaging.

TERMS OF EQUIPMENT LOAN AGREEMENT

This Agreement is for the Temporary use of the above equipment. The undersigned, hereinafter referred to as the Licensee, enters into a Loan Agreement with Lake Beverage Corporation as follows: The Licensee has agreed to borrow the items herein described upon the express condition that responsibility for equipment remains with the Licensee from the time of delivery or pick-up until time of return. In the event the Licensee fails to return any item(s) at the agreed time, or fails to abide by any of the other terms of this contract, the Licensee will be charged accordingly based on the time the item is in the Licensee's possession. The Licensee will pay for the replacement of said item(s) at the designated replacement cost as indicated above. Lake Beverage Corporation agrees to supply the above item(s) in "as is" condition. The Licensee agrees to indemnify and hold harmless Lake Beverage Corporation from any questions of personal liability for any accident or injury arising out of, or through use of Lake Beverage Corporation equipment and/or materials. The Licensee will be responsible for the good condition of the above stated draught vehicle and will exercise reasonable care so as to prevent damage or theft of the equipment and its components. The Licensee understands that Lake Beverage Corporation operations staff will determine the final count for the product purchase. There will be a \$300 non-refundable draught trailer rental fee added to the product invoice.
